China's energy storage incentive policies are imperfect, and there are problems such as insufficient local policy implementation and lack of long-term mechanisms. Since the frequency and magnitude of future policy adjustments are not specified, it is impossible for energy storage technology investors to make appropriate investment decisions.

What are the Development Goals for new energy storage in China?

The plan specified development goals for new energy storage in China,by 2025,new energy storage technologies will step into a large-scale development period and meet the conditions for large-scale commercial applications.

Can China develop energy storage technology and industry development?
