What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

What is the 'guidance on accelerating the development of new energy storage?

Since April 21,2021,the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'), which has given rise to the energy storage industry and even the energy industry.

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1,p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes &Standards (C&S) gaps.

What factors should be considered when selecting energy storage systems?

It highlights the importance of considering multiple factors,including technical performance,economic viability,scalability,and system integration,in selecting ESTs. The need for continued research and development,policy support,and collaboration between energy stakeholders is emphasized to drive further advancements in energy storage.

What is energy storage technology?

This guidance is also primarily targeted at variants of lithium-ion batteries, which are currently the most economically viable energy storage solution for large-scale systems in the market.
