What are the benefits of energy storage power stations?

Energy storage stations have different benefits in different scenarios. In scenario 1, energy storage stations achieve profits through peak shaving and frequency modulation, auxiliary services, and delayed device upgrades. In scenario 2, energy storage power station profitability through peak-to-valley price differential arbitrage.

What is shared energy storage & other energy storage business models?

Through shared energy storage and other energy storage business models, the application scope of energy storage on the power generation side, transmission and distribution side, and user side will be blurred. And many application scenarios can realize the composite utilization of energy storage according to demand.

What are the emerging energy storage business models?

The independent energy storage model under the spot power market and the shared energy storage model are emerging energy storage business models. They emphasized the independent status of energy storage. The energy storage has truly been upgraded from an auxiliary industry to the main industry.

What is energy storage in a substation?

The energy storage is installed downstream of the power transmission and distribution equipment that originally needs to be upgraded to delay or avoid capacity expansion. The energy storage equipment in the substation can be used as a backup power supply to directly supply power to the DC load.

What is user-side energy storage?

User-side energy storage can not only absorb renewable energy such as solar energy, but also maintain a stable power supply for houses. German energy supply company which called SENECSIES adopts a "free lunch" energy storage business model. SENECSIES installs energy storage systems for users who own home photovoltaics.

Can energy storage provide multiple services?

The California Public Utilities Commission (CPUC) took a first step and published a framework of eleven rules prescribing when energy storage is allowed to provide multiple services. The framework delineates which combinations are permitted and how business models should be prioritized (American Public Power Association, 2018).
