European officials are in a tangle over how to manage a flood of Chinese imports - cheap solar panels led to a surge of solar energy installations. Europe enjoyed a bumper year for green energy, 40% over 2022, but the imports have been crushing the region's few solar panel suppliers. Governments and industry are split over how to respond.
