Federal Rebates Federal Solar Tax Credit. The Investment Tax Credit (ITC), also known as the federal solar tax credit, is a nationwide incentive enabling individuals to receive a tax credit for expenses incurred from the installation of solar panels. This credit provides owners of solar systems a deduction of 30% off the total cost of their system.

If you have installed solar PV panels or other eligible renewable electricity generation in your home or business, you may be able to earn money through the Smart Export Guarantee (SEG).
