Is foreign help enough to fix Iraq's energy problems?

Foreign help is not enoughto fix energy issues, domestic reform is necessary. This past July, Iraq and France's TotalEnergies finalized the Gas Growth Integrated Project, a \$27 billion energy deal aimed at Iraq's natural resources and improving the country's electricity supply.

Should Iraq rely on state financing for energy projects?

There has scarcely been a more urgent time for Iraq to pursue crucial reforms in its energy sector to ensure that investment continues even when government revenues have been decimated by low oil prices. The alternative of continuing to rely on direct state financing of large projects only increases the risk that these projects are delayed.

Will IEA support Iraq's Energy reforms?

As Iraq's newly formed government begins to tackle the long list of considerable challenges it faces, the IEA stands ready to support the country in its efforts to enact the reforms that will help its energy sector - and its economy - meet its vast potential.

Should Iraq trade oil for Iranian gas?

According to Prime Minister Mohammad Shia al-Sudani, by trading Iraqi oil for Iranian gas, Iraq would avoid power cuts in the summer while working on the deals to complete gas capture and extraction projects that would help make the country self-sufficient.

Can Iraq achieve energy self-sufficiency without regional aid?

However, the path to energy sufficiency remains a considerable challenge for Iraq even with regional aid. Without domestic reforms to address the underlying causes of the energy crisis, Iraq's journey towards achieving energy self-sufficiency is still a considerable distance away.

Will Saudi Arabia export electricity to Iraq by 2024?

A noteworthy upcoming project entails an electricity interconnection between Saudi Arabia and Iraq, expected to be completed by 2024. In the initial phase, Saudi Arabia is set to export 1 gigawattof electricity to Iraq through a 270-mile line.
