The global solar power market size was valued at USD 253.69 billion in 2023 and is projected to be worth USD 273 billion in 2024 and reach USD 436.36 billion by 2032, exhibiting a CAGR of 6% during the forecast period. India has generated 75.57 BU of solar power in the first eleven months of FY24. Power generation from renewable energy sources (not including hydro) stood at 22.41 billion units (BU) in January 2024, down from 25.79 BU in January 2023. India added a record 18.48 GW of renewable energy capacity in 2023-24, a 21% increase over the previous year.

India's installed solar power generation capacity stands at around 35 Gigawatt today, while it was a mere 0.2 GW in 2010. This commendable growth in the last decade has largely been achieved through imports of solar equipment from China, Singapore, Vietnam, and Taiwan.
