From 1 February 2024, you won't pay any VAT on batteries for solar panels (previously you had to pay 20% VAT, unless you bought it as part of a solar panel system). So now you can install a standalone energy storage battery or add one to your existing solar PV system, and you'll pay 0% VAT. From 1 April 2027, this is set to increase to 20% VAT.

As with capacity, there is no set definition regarding storage duration. According to US Energy Information Administration, storage duration depends on how grid scale batteries are used. It notes the following regarding capacity-weighted average storage duration in ...
