What is the European solar PV industry alliance?

To accelerate solar photovoltaic(solar PV) deployment in the EU, the European Solar PV Industry Alliance was launched in 2022 to develop an EU solar PV industrial ecosystem to help secure and diversify supplies of solar PVs.

How does the EU support the European solar PV manufacturing sector?

Over the last years, the EU has taken initiatives to strengthen its support to the European solar PV manufacturing sector, which includes several globally competitive companies in several steps of the value chain.

What is the European Solar charter?

The European Solar Charter marks the latest step in the Commission's actions to support solar panel manufacturing in Europe. Previous measures include, amongst others, a proposal for a Net-Zero Industry Act, which is now provisionally agreed by the co-legislators, and the establishment of the European Solar Photovoltaic Industry Alliance.

What is the EU solar energy strategy?

Published as part of the plan,the EU solar energy strategy aims to deploy over 320 GW of solar PV by 2025,more than doubling the 2020 output,and almost 600 GW by 2030. To meet these objectives,the strategy The European Solar Photovoltaic Industry Alliance aims for resilience and strategic autonomy across the European value chain.

Who can join the solar PV Alliance?

The alliance is open to all public and private entities with relevant activities in the area of solar PV, including companies and associations, social partners, education and training providers, research and technology organisations, investors, civil society organisations, and representatives of EU countries, regional and public authorities.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

The European Commission has published its "Horizon Europe Strategic Plan 2025-2027," where it decided to form an official Co-Programmed European Partnership for solar photovoltaics with the European Technology and Innovation Platform (ETIP PV). The ...
