

## Serbia energy storage power station signed

Public Power Corporation (PPC), DEPA Trade and Damco Energy (part of the Copelouzos Group) have signed an agreement for the purchase of a 51 % share by PPC in Electroparagogi Alexandroupolis Monoprosopi, a company planning to build and operate an 840 MW gas-fired power plant in Alexandroupoli.

Infrastructure Minister Milutin Mrkonjic and Chinese Ambassador Zhang Wanxue signed on Thursday a loan agreement for the overhaul of a Serbian power plant. The money will go toward the first phase of the project, specifically workd that will be done on blocks B1 and B2 of the Kostolac thermal power station, located in eastern Serbia.

These are 1 TWh of wind power plants with a total power of 398 MW (373 MW on transmission and 25 MW on the distribution system), 0.3 TWh of small HE with a total power of about 65 MW, 0.8 TWh of other power plants (biogas, biomass, cogeneration, waste) with a total power of about 100 MW, and a 0.01 TWh solar power plant with a total power of 9 MW.

Earlier in late June, Electrohold commissioned the largest solar power plant in Bulgaria - the 123 MW Verila solar power plant. Through it, Electrohold Trade will supply the telecommunications company Yettel and the telecommunications equipment company CETIN with green energy for the next 10 years, after the two parties signed a power purchase agreement ...
