

# Slovakia shared energy storage project tender

Global energy storage system integrator and services provider Fluence is currently thought to be putting the finishing touches on a four-project, 200MW/200MWh portfolio of BESS installations for Lithuanian state-owned energy group EPSO-G and its special purpose company formed for the project, Energy Cells.

The Slovak government has issued a tender titled "ELEKTROLYZÉR NA VÝROBU H<sub>2</sub> V ENO," published on September 23, 2024. Interested parties must submit their proposals by October 14, 2024. This tender is pivotal for advancing the hydrogen industry within Slovakia, marking a significant step towards sustainable energy solutions in the region.

Numerous solar-plus-storage projects that won contracts in the 2020/21 Tender have come online or started construction this year, as reported by Energy-Storage.news. Developers Enerparc and Qair commissioned projects in March and April respectively while renewable energy firm ABO Wind and two utilities launched the construction of projects in ...

As previously reported by Energy-Storage.news, the two projects will be in Kiisa in the Saku Rural municipality and Arukylä in the Raasiku Rural municipality and will provide emergency reserve power. Kiisa is the location of an emergency power plant operated by TSO Elering. The battery energy storage park and its substation will be connected to the electricity ...

Bulgaria's Ministry of Energy has launched two tenders to add 1,425MW of renewable power generation to the grid and 350MW of battery energy storage system (BESS) projects. The ministry said the main objective of the investment, totalling BGN535.1 million (US\$298.2 million), is to increase the share of clean energy in Bulgaria by supporting ...

The company said it deployed the largest battery energy storage system in Slovakia back in 2020, another 432kWh system, for energy supplier G& E Trading. However, that was later eclipsed by a 5.3MW/2.9MWh system that Switzerland-headquartered firm Leclanché installed for frequency regulation at a medium voltage grid of a natural gas plant ...

The reverse auction was launched with a Notice Inviting Tender (NIT) issued by SECI on 15 March for the Request for Selection (RFS). Buying entities for the solar-generated power will set 2-hour periods each day during which energy will be drawn from the energy storage system (ESS), determined on a day-ahead basis.

The list of winners in Greece's maiden tender for standalone battery energy storage system (BESS) projects includes seven companies with 12 proposals, Energypress reports.. The government of New South Wales in Australia has initiated a tender for long-duration energy storage projects, aiming to secure 1GW of eight-hour storage capacity. The move is part of the state's strategy to transition towards renewable energy sources while ensuring a reliable and affordable energy supply.

PGE's unique on a European scale energy storage project in Żarnowiec with a capacity of no less than 200 MW has obtained the first license promise in Poland for electricity storage in a large-scale electrochemical energy storage facility. The promise was issued by the President of the Energy Regulatory Office.

Utility and IPP Enel has sold a 49% stake in its subsidiary that will own and operate 1.7GW of battery energy storage system (BESS) projects in Italy, to investor Sosteneo.

That BESS project was an 8-hour duration lithium-ion (Li-ion) project submitted by RWE, with 50MW output to 400MWh capacity, as reported by Energy-Storage.news in May. 980MW/2790MWh of BESS, 95MW of VPP win contracts. This time out, there were no long-duration energy storage (LDES) winners.

The launch of this first tender aimed to co-locate energy storage with other renewable sources, mainly solar PV, and aimed to fund at least 600MW of projects with a fund of EUR150 million (US\$162 million) in capital expenditure for the projects..
